D. Call Letter for Interview:

Interview: Intimation/call letter for interview, where required, will be sent by email or will be uploaded on Bank's website. **NO HARD COPY WILL BE SENT.**

E. Proof of Identity to be Submitted at the interview

The candidates must bring one photo identity proof such as Passport/Aadhar/ PAN Card/Driving License/Voter's Card/ Bank Passbook with duly attested photograph in original as well as a self-attested Photocopy thereof. failing which or if identity of candidates is in doubt the candidate will not be permitted to appear for the interview.

F. Action Against Candidate Found Guilty of Misconduct:
