- i) Contractors having or planning to open an office in Tamilnadu / Pondicherry shall alone need to apply.
- ii) Average annual financial turnover during the last 3 years, ending 31.03.2019, should be at least Rs.1.10 Crore.
- iii) Contractors having successfully completed similar Heritage restoration works for Central/State Govt/PSU/PSU financial institutions/Reputed private entities during the last 7 years ending 31.03.2019 and satisfy any one of the following requirements shall alone be considered:
 - a) One work costing not less than Rs.272 lakhs **(or)**
 - b) Two works costing not less than Rs.170 lakhs each **(or)**
 - c) Three works costing not less than Rs.136 lakhs each.
- iv) Contractors with adequate exposure and expertise in undertaking similar works with a team of specialists for executing major Heritage restoration works shall be preferred.
