d) The Successful bidder shall be required to submit the final prices, quoted during the –e Auction as per the annexure after the completion of the e- Auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of e- auction.

e) During e- Auction , if no bid is received within specified time, State bank of India at its discretion may decide to revise opening price/ scrap the e- Auction process / process /proceed with conventional mode of e tendering.

f) The Bank /service provider for e- Auction shall have not have any liability towards bidders for any interruption or delay in access to the site irrespective of the causes.

g) The bidders are required to submit acceptance of the terms & conditions and modalities of e- Auction adopted by the service provider, before participating in the E- Auction.

h) The bids once submitted by the bidder, cannot be cancelled/withdrawn and the bidder shall be bound to buy the property at the final bid price. n) The Authorised Officer/Bank is not bound to accept the highest offer and has the absolute right to accept or reject any or all offer(s) or adjourn/ postpone/ cancel the e-Auction or withdraw any property or portion thereof from the auction proceedings at any stage without assigning any reason thereof. The sale is subject to confirmation by the secured creditor.

o) In case of forfeiture of the amount deposited by any defaulting bidder, he shall neither have claim on the property nor on any part of the sum for which it may be subsequently sold.

p) The successful bidder shall bear the applicable stamp duties/ additional stamp duty/ transfer charges, Registration expenses, fees etc. for transfer of the property in his /her name.

taxes, GSTN, rates, assessment charges, fees etc. owing to anybody shall be the sole responsibility of successful bidder only.
