2. The Bank is having actual possession of the secured assets.

3. To the best of knowledge and information of the Authorised Officer, there is no encumbrance on the property/ies. Although it is learnt that there are a few attachments covering the property in OS No. 6968/2015 and OS 223/2017 in the files of Munsiff Court, Thrissur and OS 274/2015 in the file of Sub Court of Thrissur (as per EC), the same are not binding on the bank. 8. It shall be the responsibility of the interested bidders to inspect and satisfy themselves about the property before submission of the bid.
9. The e-Auction/bidding of above properties would be conducted exactly on the scheduled Date & Time as mentioned against each property by way of inter-se bidding amongst the bidders. The bidder shall improve their offer in multiple of the amount mentioned under the column "Bid Increment Amount" against each property.
