The State Bank of India is looking for Circle Defence Banking Advisors (Army) on contractual basis. The details relating to the post, eligibility criteria and other terms & conditions are as under:-

DETAILS OF THE POST

- No. of Vacancies – 5
- Vacancies are for unreserved/general category. However, candidates from the reserved categories can also apply on same terms and conditions.
- Postings will be in any of the following Circles of the Bank – Bhopal, Chandigarh, Chennai, Hyderabad & North Eastern.
- Maximum age for applying for the post is 60 years (as on 01.02.2012).
- Candidate must be an Army Officer retired in the rank of Brigadier or Major General.
- The selected candidate will be appointed on contractual basis for a period of two years, subject to half yearly review.
- Candidate should be medically fit to move freely and undertake tours independently and should not suffer from any major ailment(s), which may adversely impact his performance in the Bank.

COMPENSATION PACKAGE

- CTC Rs. 20.00 lacs at Metro centres and Rs. 18.00 lacs at other centres. The basic pay is Rs. 80,000/- p.m. and remaining portion will be paid as HRA, conveyance allowance and others. Deductible portion of monthly pension will be reduced. The approximate CTC payable after deducting the pension drawn by them will be Rs.14.00 lacs p.a. at Metro centres and Rs.12.00 lacs at other centres.
- Other facilities – will be eligible for mobile phone expenses, subject to ceiling. The official will also be eligible for TA, HA, lodging & boarding expenses etc during official duties.

ROLE EXPECTATIONS AND JOB PROFILE

- CDBA shall liaise with local units of Defence forces/Paramilitary forces for expanding the relationship between Army/ other forces and SBI and for spreading Defence Salary Package. Acting as one-point contact for the Defence/Paramilitary establishments in their area for complaints redressal.

SELECTION PROCEDURE :

- Valid applications will be short listed by the committee of specialists/experts and shortlisted candidates will be called for Interview.
- Final selection will be on the basis of performance of interview alone.
- The candidates called for interview will be entitled to 1st class/AC III Tier to & fro railway fare or bus fare by the shortest route from their residence in India, given in the application, to the place of interview on production of evidence of travel (rail/bus ticket).

 - Discharge Certificate.
 - A one-page write-up as separate annexure, describing career and performance achievements in the Army and details of gallantry awards/medals if any with supporting documentation.
 - Candidates serving in Government/ Quasi-Government Offices, Public Sector undertaking including Nationalized Banks and Financial Institutions will be required to submit "No Objection Certificate" from employer, at the time of interview.
