

PRE – QUALIFICATION OF AGENCIES FOR SUPPLY & INSTALLATION OF LED OUTDOOR VIDEO WALL(DIGITAL BOARD) DISPLAY FOR BANK ADVERTISEMENT IN THE BANGALORE AND OTHER CITIES IN KARNATAKA STATE.

State Bank of India, Local Head Office, No.65, St. Marks Road, Bangalore - 560001, propose to display static LED outdoor video wall (digital board) display. The total initial outlay for the said work would be around Rs1.00 crores. Bank therefore, invites applications for empanelment of Agencies for supplying and displaying static LED outdoor video wall(digital board) for Bank's advertisement in Bangalore and other cities in Karnataka State. If required the advertisements shall be customized and installed as per the availability of space.

Eligible agencies desirous of pre – qualification and requested to take note of the following.

1. This advertisement is given for pre – qualification of agencies for supply & installation of LED outdoor video wall(digital wall) displaying Bank's advertisement. The companies/ agencies who have displayed LED outdoor video wall (digital board) for the Bank in the past will also have to apply for the empanelment.
2. It is imperative that the Agencies should have requisite expertise for displaying LED outdoor video wall (digital board) of different sizes along important strategic locations across Karnataka such as National Highways, State Highways, All District Head Quarters, Taluk Head Quarters, Railway Station, Near Air Ports, Bus Stand and important public assembly places etc.. Agencies should also have service station, sales office and permanent office set up in the State of Karnataka, preferably in Bangalore. Agencies should have valid registration for GSTN, PAN, TAN, EPF, labour licence, policy for workmen compensation, ESI registration.
3. It is also essential that the agencies should have skill and knowledge to suit the various requirements of the Bank and should submit a proof of having displayed LED outdoor video wall (digital board) across State of Karnataka on their own.

The Bank reserves the right to :

1. Select or reject any or all applications without assigning any reason there for. The Bank also reserves the right to postpone the process of pre-qualification due to administrative exigencies. Bank also reserves the right to de-panel the agencies if their performance is not found satisfactory.
2. The office and work sites of Agencies who fulfill the eligibility criteria shall be inspected by the

committee formed by the Bank prior to final empanelment and the decision of the committee as regards to capacity/quality/ workmanship of the works undertaken by the Agencies and suitability to carry-out the works shall be final. If any information furnished by the applicant is found incorrect at a later stage; he shall be liable to be debarred from the tender/ taking up the works.

3. The tenders for the work shall be issued to the pre-qualified agencies and separate notice inviting tenders will not be published in news paper. The notice inviting tenders will be sent to pre-qualified agencies by e-mail or e-tenders will be published in Bank's website for pre-qualified agencies and e-tenders/reverse auction process shall be held on separate e- tendering platform through Bank's approved agencies which shall be limited to pre-qualified agencies..
4. Incomplete applications of the applicants, who do not submit the application indicating valid e-mail ID, registration under GST, Income tax PAN , annual turnover for the past 3 years and other registrations as referred above, relevant proof of completion of the work, copies of work order , photograph etc. will be summarily rejected.

Eligibility Criteria for empanelment of Agencies

Only those agencies who have undertaken similar works and worked for public sector undertaking , MNC's State & central Govt, PSU Banks, reputed institutions/software companies, reputed hotels / tourism department etc. and have executed and displayed LED outdoor video wall (digital board) across Karnataka and furnish documentary evidence of complying with the following criteria, shall be considered for pre-qualification. In case Bank desire to visit the site of installation, the applicant is required to arrange for permission from the users.

1. Average annual financial turnover during the last 3 years preceding current financial year ended 31st March should not be less than Rs.60 lakhs.
2. Should have successfully displayed advertisements during the last 5 years ending last day of month previous to the one in which application is submitted, as under.(ie working in this field at least for the last 5 years)
 - (a) either three works, each costing not less than Rs. 40 lakhs or
 - (b) two works, each costing not less than Rs.50 lakhs or
 - (c) one work costing not less than Rs.80 lakhs.
3. should not have incurred loss for 3 consecutive years during last 5 years.
