1. The comprehensive AMC charges per unit per year will be paid for four services in a year apart from any number of breakdown calls with a response period of 3 hours on receipt of complaint. The scope of work includes replacement of old batteries(cells) and maintenance/ replacement of antenna and charger
2. If the technician is not visiting the site against complaints, a penalty of ₹200.00 per day to be levied. And same will be recovered/ adjusted in quarterly payment.
