- 1. All columns of the tender documents must duly fill in and no column should be left blank. - 2. In case the space in the tender document is found insufficient, the lessors may attach separate sheets.

- 12. The income tax and other taxes as applicable will be deducted at source while paying the rentals per month. All other taxes and service charges except service tax/ GST, if applicable, shall be borne by the landlord.
