1	Annexure-A	Annexure – D to be submitted after due completion of Reverse Auction and by successful vendor only.	Should they upload Annexure -D for Make and Model as part of e-bidding document.  Our comment: Annexure – D has to be submitted along with final price bid only by successful bidders.
2	Annexure-E (Illustration)	The 'Proportion to Total Cost' percentage mentioned here will have to be maintained in the final price quote also by the L1/TC1 Bidder. The percentage should be mentioned in two decimal places. Variation in the final price should not exceed +/- 5%. See illustration at the end.	Our Comments: Representative has been explained suitably.
3	18	Performance Bank Guarantee:  i. An amount of Rs 3 lacs per AO  ii. Rs 2 Lacs for LHO & BPR outfit on being awarded the contract.	As per Govt of India, Office of Development commissioner (MSME), Public Procurement Policy Division, Nirman Bhavan, New Delhi dated 20.11.2020, performance <u>Security</u> has been reduced from existing 5-10% to 3%.  Our Comments: (i) EMD is Nil and the Performance security has been worked out at 3% of the anticipated / expected work order. There are intrinsic limitations to the possibility of predicting the future demand based on past Purchase Orders.
4	17	Terms of Payment Para 22	Please clear the payments terms in tender about who will make the payment AO/ RO & what is the base of payments. Number of days should be specified.  Our Comments: Payment would be made as per periodicity prescribed under various acts / law subject to satisfactory completion of work/s and submission of acceptable invoices at the appropriate office.
5	40	Any component that is required to be replaced/ changed is to be authorized by branch official in the case of Non-comprehensive AMC. The vendor has to submit "CR" change request in the format as per Annexure "H".	No clarity about the age of the system. Example: Analogue DVR doesn't support the new HD camera.  Our comments: The query/ suggestion is not tenable. In the ever-evolving Technology, CCTV installed today cannot be junked before its serviceable life period and it is for these reasons, AMC is entered. Bank would take an appropriate administrative decision on a case-to-case basis.
6	45	Annexure -E, Item No: 44: Dismantling and reinstalling the existing CCTV system to another location within a radius of 10 Km for 1 Branch (Excluding the cost of hardware / peripherals).	The bank has not asked for the charges of the re-installations/ shifting etc.  Our Comments: Please be guided by Annexure -E , Item No: 44.
