If any applicant, has submitted his/her application directly to LHO/AO/RBO, he/she needs to submit the application afresh to the nearest SBI Branches/ Business units situated in geographical area of Chandigarh Circle.</p> <p>Further any application received after last date i.e; 20.08.2023 shall not be entertained.</p>
<p>(New Clause)</p>	<p>The applicants who have already submitted their application without any address of office situated in geographical area of Chandigarh Circle or without any proof of having conducted valuations in geographical area of Chandigarh Circle, those applicants shall be required to submit proof of having conducted valuation as well as address proof of office situated in geographical area of Chandigarh Circle, as the case may be, latest by 20.08.2023 to the branch/business unit situated in geographical area of Chandigarh Circle where the application was submitted by them. In case of failure to submit the relevant documents of proof, the application will not be considered.</p>
