## **Eligible Agencies**

- i. Agency should be engaged in Detective work, through legal means conforming to regulations, related to asset tracing at both domestic and offshore locations for the last 2 years.
- Agency should have working/association with any Public or Private Sector Bank/Fls/LIC/GIC, etc. and Government agencies like CBI, ED, SFIO, etc. for a period of 2 years (minimum). Agencies having presence in multi states may be given preference subject to fulfilling other mandatory eligibility criteria/qualifications.
- iii. Generally Corporate or LLPs will be preferred for empanelment. However, Individuals and Sole Proprietary concerns who fulfil the other eligibility criteria and having successful track record may also be considered for empanelment. In such case, Branches/Operating units will give detailed justification with proof of successful track record for each case.
  - iv. Agency should have a valid TAN and PAN number and should have submitted last 2 years IT returns.
  - v. Agencies should not have been blacklisted by any bank or financial institution or State/Central Government or any other regulatory authority
  - vi. No criminal proceedings should be pending against the Agencies before Courts/CBI/any Law Enforcement Agencies. The criminal/antecedent verification will be done through Police verification post application.
