**TERMS AND CONDITIONS FOR SALE OF CARS**

1. The offer should be submitted in two separate envelopes containing technical and price bids, put together in a 3<sup>rd</sup> envelope which should be addressed to

a) **Envelope No.1- (Page No. 1 to 5)**

It should contain car no, the signed terms and conditions and a Bankers Cheque / DD in favour of State Bank of India, payable at Hyderabad, towards the Earnest Money Deposit (EMD) @ Rs 10,000/- per car. For example, if a bidder wants to bid for 2 cars he has to submit a Banker's Cheque / DD of EMD of Rs 20,000/- (Rupees twenty thousand only). The cover should be superscribed as “Technical bid”

b) **Envelope No.2 (Page No. 6 & 8)**

It should contain the price against each car with vehicle number duly signed by the bidder. The cover should be superscribed as financial bid.

c) **Envelope No. 3**

It should contain SEALED 1<sup>st</sup> and 2<sup>nd</sup> envelope. This cover should be superscribed as ‘Quotation for auction of cars’ along with bidder's Name, address and contact number. Email may also be provided.

2. The Banker's cheque / DD should be in favour of State Bank of India issued by a Nationalized Bank / Scheduled Commercial Bank and shall be payable at Hyderabad.
3. There are **02** cars to be sold as mentioned in the price bid format. The basic details of cars such as Model, Year of purchase, fuel type, transmission type etc. are provided. The bidders have to ensure the correctness through Liaison Department.

4. A bidder may **quote for any car / all cars, however, price for individual cars shall be quoted.**
5. The bidder should deposit an amount of Rs. 10,000/- per car as EMD. The said EMD will not carry any interest and the same shall be refunded to the unsuccessful bidder within 30 days from the date of opening of the bids. The EMD money of successful bidders shall be adjusted against the purchase price of the cars.
6. The State Bank of India reserves the right to accept or reject any or all the tenders in whole or part without assigning any reasons for doing so and do not bind themselves to accept any or all the tenders.
7. The quotations **not accompanied EMD shall be rejected outright.**
8. The bidders shall sign in all pages of the tender document. Unsigned / incomplete / not as per Bank's format shall be rejected outright.
9. The quotations shall remain valid for 90 days for acceptance from the last date of submission of the bid. The vehicle will be available for inspection / display at State Bank of India, Local Head Office, Gunfoundry, Hyderabad between **11.00 am to 3.00 PM from 18/05/2023 to 25/05/2023** (except Sundays and Public Holidays). **No self-test driving will be permitted.** A driver will be arranged by Bank for test riding the car.
10. The successful bidder shall take the delivery of the vehicles within 15 days from the date of intimation letter issued by the Bank against full payment by DD / Banker's cheque, failing which, the Bank reserves the right to forfeit the EMD.
11. The last date of receipt of offer is 03.00 pm on **25.05.2023**. The sealed offers received will be opened on same day at 04:00 pm on 2<sup>nd</sup> floor, Premises & Estate Dept. State Bank of India, Local Head Office, Gunfoundry, Hyderabad and the parties submitting their offers may be present thereat.

15. If there is any anomaly between rates quoted in figures and rates quoted in words, then the rates quoted in words will be considered and the quoted price.
16. In case two bidders have quoted the same price against one car than in such case the bidder who has submitted offer for maximum number of cars will considered successful. In case both the bidders have quoted for same number of cars, only those bidders will be advised to submit their revised offer for the same car in a sealed cover and highest of the that bid shall be declared as successful bidder.
