**TERMS AND CONDITIONS OF PRICE BID: -**

- 1) Online prices shall be entered online in the format provided in <https://tenderwizard.com/> in respective Section i.e. I & II.
- 2) The price entered in section I against each item shall include the design, engineering, manufacturing, testing, packing, forwarding, loading/ unloading, insurance, installation, testing, commissioning and handing over and shall include the due proportion of labour, preliminaries, overhead charges and profit and shall represent the value of the particular item installed, completed, tested and set to work as part of this contract.

- 3) Bidders to quote strictly as per the BOQ.
- 4) Failure to comply with above shall lead to disqualification of bidders.
- 5) The amount of AMC will be taken into account while evaluating the overall bid amount.
- 6) The price entered in section II shall include charges for Comprehensive Annual Maintenance Contact (AMC) including the cost of spares & consumables, excluding taxes etc. fixed for 4 years after expiry of the defects liability and free maintenance period of 01 year. GST shall be paid extra as per prevailing rates.
- 7) Evaluation of the financial bids shall be based on Grand Total Amount (Section I + Section II) quoted by the bidder.
- 8) Initially work order shall be placed to the contract for SITC of lifts only excluding AMC cost. AMC amount will be paid to the OEM after entering into the agreement with Bank after expiry of defect liability period.
- 9) E-reverse auction shall be conducted on Total amount of section I and II.
