NOTE:

1. GST amount should not be included in the Commercial Bid and shall be paid extra as applicable by Govt of India. The successful vendor has to submit system generated GST tax invoice incorporating Bank's GST in number and vendor GST no. Manual GST invoices will not be accepted.
2. Current Wages as per Central Government Minimum Wages.
3. If the amount quoted by the bidder in the Price Bid is less than 3.85% and should not exceed 7% including transaction charges. If the percentage quoted is beyond the above slab the tender shall summarily be rejected. If Charges towards Utility items/ Consumables i.e Uniform, Tools, Pest Control & Rodent Treatment etc. is less than Rs.2500/- per month, the bid will be automatically rejected.
4. In case more than one bidder is found at the Lowest quoted price (L1) in all 5 clusters (i.e. cluster I, II, III, IV, V) then L-1 shall be decided by draw system and only one bidder will be selected in different 5 clusters i.e. 5 different bidders will be selected for cluster- 1, 2, 3, 4 & 5.
5. Bill should be raised for actual working days in a month i.e. 24/25 days.
6. If any vendor quoted less than minimum amount prescribed in Sr No A, E & H will be rejected automatically and disqualified from tender.
